SUMMARY

San Antonio International Airport served 711,596 total passengers in March 2016, a (3.9%) decrease as compared to March 2015. However, calendar year-to-date (CYTD) traffic continues to show positive growth, having increased 1.5%, or 1,947,496 total passengers. In March, total air cargo increased 4.4% year-over-year to 19,680,096 pounds. CYTD total cargo softened slightly versus the same period in 2015 to 55,059,483 pounds, or (3.2%). Please see Exhibit A for a detailed breakdown.

DOMESTIC PASSENGERS

Scheduled domestic capacity, or seats, increased in March 2016 year-over-year to 427,958 monthly departure seats, an increase of 9,060 seats, approximately 2.2%. However, despite the increase in seats, total domestic passengers trended down (3.0%). Generally speaking, the passenger traffic reported by the airlines tended to trend with the change in capacity with the exception of Southwest Airlines. It is not yet understood what contributed to the decline in domestic traffic for the month, however, we will continue to monitor changes on a monthly basis in comparison to historic periods.

When comparing year-over-year domestic capacity changes, the results were based on the following:

- Alaska Airlines: used larger equipment on their SEA route
- Allegiant Air: started new service to FLL, LAS and SFB in November 2015
- American Airlines
 - DFW: made day-of-week adjustments starting in November 2015
 - LAX: added one less-than-daily flight in May 2015
 - PHL: post-merger with US Airways, service to PHL was eliminated in October 2015

INTERNATIONAL PASSENGERS

Scheduled international capacity, or seats, decreased in March 2016 year-over-year to 20,451 monthly departure seats, a decrease of 2,640 seats, approximately (11.4%). However, total international passengers outpaced the decrease in seats, declining (19.4%). Generally speaking, the passenger traffic reported by the airlines tended to trend with the change in capacity with the exception of Interjet. In addition to capacity adjustments, the continuing devaluation of the peso to the dollar may be contributing to decreased leisure travel between the two countries.

When comparing year-over-year international capacity changes, the results were based on the following:

- Aeromexico: reduced frequencies to MEX from twice to once daily in September 2015, except for peak travel periods
- VivaAerobus: ceased service from SAT to MTY in August 2015.

UPCOMING SCHEDULE CHANGES

Frontier Airlines will be launching new nonstop service to four destinations in May 2016.

- Atlanta, GA (ATL): effective May 13th, four times per week utilizing 150-seat Airbus A319 aircraft
- Denver, CO (DEN): effective May 13th, daily service utilizing 150-seat Airbus A319 aircraft
- Las Vegas, NV (LAS): effective May 15th, three times per week utilizing 150-seat Airbus A319 aircraft
- Philadelphia, PA (PHL): effective May 13th, four times per week utilizing 150-seat Airbus A319 aircraft.
